1. The Electricité du Cambodge (EDC), now invites sealed bids from eligible and qualified bidders for procurement of 3,900 SHS-50 Wp, 6,353 SHS-5Wp, 2,400 Battery 55 Ah 12 Vdc and 11,450 LED 3 W 12 Vdc E27 Crew type base under Program for Solar Home System for Utilizing KfW Recovered Fund.
2. Procurement will be conducted through International Competitive Bidding Procedure -Single Stage One-Envelop Bidding Procedure in accordance with Standard Operating Procedures (SOPs).
3. This invitation is opened to all bidders from all areas.
4. Interested eligible bidders may obtain further information from and inspect the Bidding Documents at the address given below from 7:30 am to 12:00 pm and 14:00 pm to 17:30 pm, Monday to Friday.
5. Prospective bidders' attention is drawn to the Instructions to Bidders in the bidding documents and the qualification requirements include in Section 3 – Evaluation and Qualification Criteria.

Bidders shall collect the Bidding Documents in person. Other than payment of the nonrefundable fee specified above, there shall be no other conditions for purchase of the bidding documents. The Royal Government of Cambodia (RGC) will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by the RGC, if it at any time determines that the firm has engaged in corrupt or fraudulent, coercive or collusive practices in competing for or in executing a contract.
