The Royal Government of Cambodia (RGC) has received loan from Asian Development Bank Loan No.2979-CAM (SF) toward the cost of Medium Voltage Sub Transmission Expansion Sector Project and it intends to apply part of the proceeds of this Loan to payments under the Contract for Procurement of Computers and Servers.
2. The Electricité du Cambodge now invites sealed bids from eligible and qualified bidders for Computers and Servers.
3. Procurement will be conducted through National Competitive Bidding Procedures and under the laws and regulations governing public procurement within the Kingdom of Cambodia.

6. Qualifications requirements include are specified in ITB sub-clause 14.2 documents establishing the eligibility and qualifications of the bidder and in bid data sheet of the bidding documents.

A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non refundable fee **50.00 USD**. The method of payment will be in cash. The Bidding Documents will be collected in person at the discretion of the bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.
8. Bids must be delivered to the address given below in paragraph 11 at or before 10:00AM, 3<sup>rd</sup> September, 2014. Late bids will be rejected. Bids will be opened in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person at the address given below at 10:00AM 3<sup>rd</sup> September, 2014.
9. All bids shall be accompanied by a Bid Security in the amount of US Dollars 7,000.00. The Bid Security should be valid for 90 days from deadline after bid submission.
10. The Royal Government of Cambodia and/or the Development Partner will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by the Royal Government of Cambodia and/or the Development Partner respectively, if it at any time determines that the bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in competing for or in executing a contract.
