INVITATION FOR BID

DEVELOPMENT OF A 40 MW SOLAR PHOTOVOLTAIC POWER PLANT PROJECT
IN KAMPONG CHHNANG PROVINCE, CAMBODIA

1. Electricite du Cambodge (EDC) intends to implement a 40 MW Solar Photovoltaic Power Plant Project in Kampong Chhnang Province, Cambodia (**Project**), through international competitive bidding on Build – Own – Operate (BOO) basis. The Project will support the construction of solar photovoltaic (PV) power plants in Cambodia, and address the country’s need to: (a) expand low-cost power generation, and (b) diversify the power generation mix with an increase in the percentage of clean energy. The Project is the second phase of a 100-megawatt (MW) capacity solar power park and associated substation in Kampong Chhnang Province and a transmission interconnection system to supply power to the national grid.
2. The Royal Government of Cambodia (RGC), represented by the MME and MEF, will enter into an Implementation Agreement (**IA**) with the Developer for the implementation of the Project.
3. EDC will purchase the electric power through the Project under a long-term Power Purchase Agreement (**PPA**) to be executed between EDC and the Developer.
4. The Electricity Authority of Cambodia (**EAC**): EAC was established under the Electricity Act to regulate the power sector. The Sub-Decree and Guideline give EAC a supervisory role in relation to compliance with the rules governing the procurement process for large scale generating plant and transmission system project in addition to its obligation under the Electricity Act to issue generation and other licenses to participants in the power sector in order to regulate them effectively.
5. EDC will be the executive agency for this Project and would like to invite you to submit a bid (**Bid**) for the development of the Project as soon as possible but not later than 10:00am (local time) on *17th February, 2021*.
6. The Bid must be prepared in accordance with the “Instructions for the Preparation of the Bids” (the **Instruction Documents**).
7. Brief Scope of work for Developers: To develop, design, finance, build, operate and maintain a 40 MW Solar Photovoltaic Power Plant Project in Kampong Chhnang Province, Cambodia on BOO basis. Details of the scope of work are specified in the Bid Documents.
8. The experience and technical capacity requirements, and financial requirements, of the Developer are as set out in Section 4 of this IFB (**Pre-Qualification Requirements**).

9. Evaluations of Bids
- (a) The Pre-Qualification Requirements are the threshold levels and only the proposals of Bidders meeting these requirements shall be further evaluated.
 - (b) Only Bidders whose Pre-Qualification Proposals meet the minimum eligibility requirements above, will have their Technical Proposals opened.
 - (c) Only Bidders whose Technical Proposals are found satisfactory will have their Financial Proposals opened.
10. A complete set of Bid Documents may be purchased by interested Developers on submission of a written application by the Developer and collected by an authorized representative of the Developer, upon production of the authorized representative's authority and payment of a non-refundable fee of USD 300 (three hundred United State Dollars only) in cash.
11. The tariff proposed by the Developer shall be less than USD 0.076 per kWh and be fixed throughout the term of the PPA.

The Bid must be accompanied by an irrevocable and unconditional standby letter of credit or bank guarantee (and any replacement thereof) in an amount equal to USD 300,000 (three hundred thousand United States Dollars only) issued by a reputable bank or financial institution licensed to do business in any eligible country acceptable to EDC in a form reasonably satisfactory to EDC and which shall be valid for an additional 28 days beyond the expiration of the validity of the Proposal.
14. The Bid Documents must be duly completed and delivered to the above address not later than 10:00 AM (local time) on 17th February, 2021.
15. All Bids received in response to the IFB will be opened at 10:30 AM (local time) on 17th February, 2021.
16. EDC reserves the right to accept or reject any or all proposals or cancel the bidding process without assigning any reason. EDC shall not bear any liability whatsoever in this regard. AS
